- 3. Consideration and approval of a resolution to amend the following sections of the CAWPCA BYLAWS as referenced and dated 5/18/17:

**Article III, Section 3.1 – Board of Directors:** Modify the number of Board of Director positions to be not fewer than eight (8) but not more than sixteen (16) to accommodate a new (non-voting) officer position of Deputy Treasurer.

**Article V, Section 5.1 – Officers**: Revise language to include new Deputy Treasurer position.

Article V, Section 5.6 - Deputy Treasurer: Description of new Deputy Treasurer position.

**Article VI, Section 6.3 – Fiscal Year:** Change Fiscal Year from January 1st thru December 31<sup>st</sup> to July 1<sup>st</sup> thru June 30<sup>th</sup>.

Resolution: That the proposed amendments to Articles III, V & VI of the CAWPCA Bylaws dated 5/18/17 are approved and effective immediately.

**DISCUSSION – SUMMARIZED INTENT** 

Summary background of rationale for the proposed change:

- Changes to accommodate transition of CAWPCA Administration to the staff at NEWEA.
  Both IRS and Banking requirements made it necessary to add the NEWEA Executive
  Director to the CAWPCA Board of Directors to allow for check signatory and bank account
  access. Mary Barry will become the CAWPCA's Deputy Treasurer and will have ability to
  sign documents, issue and receive checks.
- Change fiscal end of year date from December 31<sup>st</sup> to June 30<sup>th</sup>.

- 4. Consideration and approval of a resolution to nominate a slate of Director's as recommended by the nominating committee.
